The Council discussed new street names in the new Maris Estates Addition, Angie Street will continue as Angie to the intersection of the new road and the new road from Western Street to 330th Ave. will be Shay Avenue. The placement of stop signs was also discussed. Discussion was held that 3 residents will be able to tie in their sewer lines to the new addition sewer lines and the cost will be assessed to them over a 10 year period.
